***Minors** May Play at **No Cost** **and** Must Have a Liability Waiver Form Signed by a Parent or Legal Guardian.

After 7 Days, Minors Must:

- 1)** Join the Club at Zero Cost to Play During Club Time, **or**
- 2)** Visiting Minors Who Do Not Reside in Clallam or Jefferson County and are Sponsored By a Club Member May Continue to Play at No Cost Without Joining the Club.

WHY DO PEOPLE HAVE TO PAY TO PLAY?

BRONZE MEMBERSHIP PAYMENT PLAN

We invite you to take advantage of the Bronze Membership Payment Plan! If you play several times per week and want to join the Club, this plan is for you! \$5 per play day quickly adds up to equal the \$45/mo. bronze payment plan monthly fee. Once Bronze Membership is paid for, there is no more pay to play at the Courts fees for life! (Some league and tournament fees still apply.) Bronze Membership Cost

\$ 25 Annual Dues
\$500 Capital Fund One-Time Contribution

Bronze Membership Payment Plan Cost

\$ 70 Initial Payment (\$25 annual dues plus the first installment of \$45)
\$495 \$45/mo for 11 months
\$565 Total (Includes \$40 administrative Fee, \$25 annual dues, One-Time \$500 Capital Fund Contribution)

TERMS:

- ◆ If 2 monthly payments are missed, the Member reverts to Basic Membership status and will pay \$5/day at the outdoor courts.
- ◆ If a member has defaulted on their payments, they may reinstate their Bronze Payment Plan by paying all owed monthly payments.
- ◆ No refunds will be issued.
- ◆ *Basic* Member dues already paid may be applied to the Bronze Member Payment plan within the fiscal year the dues were paid.
- ◆ Members enrolled in the payment plan will not pay \$5/day to play on the outdoor courts and are eligible for any other Bronze Member discounts.
- ◆ If a member's enrollment period extends beyond the end of the Sequim Pickler's fiscal year (6/1 - 5/31), their \$25 Bronze Member annual dues will be added to their installment plan. Thereafter, their annual dues will be due as stated in the Club's annual dues payment process.

BRONZE MEMBERSHIP PAYMENT PLAN ENROLLMENT

CARRIE BLAKE COURT PROCEDURE

FIRST SEQUIM PICKLER TO ARRIVE AT THE COURT: Get out the balls, sign-up sheets, money envelope, donation jar, Information Sign and place on the picnic table. If it is a rated play day, rated signs are available to place by courts.

ALL PLAYERS PRESENT—Please be good stewards for our Club and ask members and visitors to sign in. Be available to answer any questions players may have regarding pay to play fees, membership, etc. Questions may be submitted on the Sequim Pickler's website: sequimpicklers.net. If you see anything amiss or an issue with the courts, contact the Club's Director of Courts Operations.

LAST PERSON AT THE COURTS AT THE END OF PLAY TIME: Count the money received, ask someone to verify the count, place money in self-addressed stamped envelope and drop it in the mailbox. **SPECIAL NOTE:** Don't mail coins – they put holes in the envelopes! Simply leave coins in the money envelope and the Treasurer or other Board Member will collect coins. Put all balls, supplies, sign-up sheets, etc., back in the shed and lock up.

VISITORS POLICY

Visitors are defined as any player who is not a member and plays during Club time.



ACTIVE MILITARY AND THEIR SPOUSES have unlimited play at no cost.

All visitors will sign in at the courts. In the spirit of relationship building, visitors are granted 5 free days of play at the outdoor courts. After the 5th free day, the below rules apply:

All Visitors: Visitors at the outdoor courts are granted 5 free days of play. After the 5th free day, visitors who:

Reside outside of Clallam or Jefferson Counties and who are not sponsored by a member (see item 2 below regarding Sponsored Visitors) will be required to pay \$5 per play day. After two months of paying \$5/day to play, the Visitor will be required to join the Club.

Reside in Clallam or Jefferson Counties are required to join the Club to play during Club time. Four levels of membership are available Basic, Bronze (monthly payment plan available), Silver, or Gold.

Sponsored Visitors: Sponsored Visitors are players who are friends or family of a member and who reside outside of Clallam or Jefferson Counties. After the first 5 free days, Sponsored Visitor's shall pay at the same rate as their host members. Sponsors must be present during the Sponsored Visitor's play. After two months, a Sponsored Visitor will be required to join the Club.

Club Invited Court Exchange Visitors - Club invited court exchange visitors will always play for free.

It is at the discretion of the club Outdoor Court Coordinator, the Director of Court Operations, or the Assistant Director of Court Operations to take action or alert a Board member regarding any visitor he/she feels is abusing the intention of the rules and the goodwill of the club.
